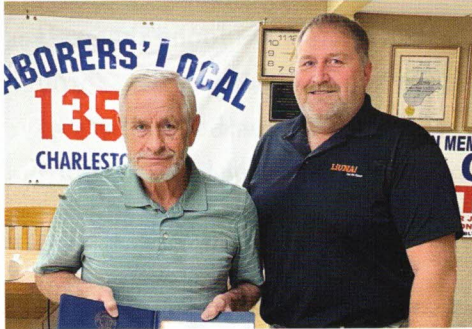
## 2024 Career Week

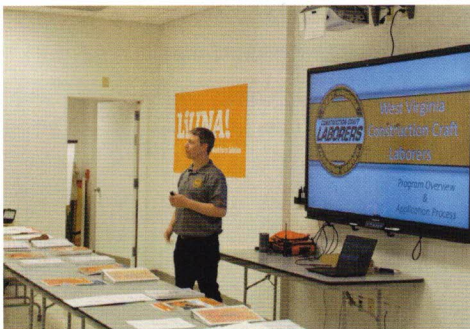
